Discussion of Game Day Parking Street Closures Proposed S.U. Game Day Traffic Changes

Closure: For Homecoming, there will only be barricades at 77th 78th, and 79th and Scenic Highway. Pembroke and Somerset will not be barricaded. Every barricade needs an officer.

Discussion of S.U.'s game day contraflow. BRPD, not S.U., mandates exiting the overpass and continuing down Harding. BRPD will not allow a right turn onto Scenic to access I-110. SU tickets also instruct to use Harding per BRPD. Pose this question to our BRPD contact, Tremaine Smith.

We must have a minimum of four officers for each of the 5 home games. Minimum of 4 hour detail. \$40.00/hour for 4 officers for five games for 4 hours each game(\$160.00/per game) is \$3200 (not including extra for homecoming).

We have money left over from the previous board (\$31,057.00)

B. Proposed Budget Amendment

Sheila Sims, Treasurer, advised we have the money to pay the patrol officers for the SU homecoming game .

Sheila Sims moved that for football season, the board use the money out of the estimated beginning fund balance (which eliminates the need for a budget adjustment) to pay for the blockades at the end of the three streets, 77th, 78th, and 79 and to pay for the police patrols on game day.

Game Day Parking Restrictions

Restricting parking to one side of the street for homecoming. We can get No Parking Signs. If we decide to restrict parking for every home game, we can alternate the no parking side of the street.

Must keep some street open for access by emergency vehicles.

Future Item Agenda:

There are about 4-5 houses that are in Hastings Heights. We can propose inviting those property owners to contract with our SHNCPID and pay their \$100.00 per lot, either individually, or as a neighborhood group, to be included in the patrols. We can consider 2 extra officers if Hastings Heights agrees to contract and participate with SHNCPID. There is a concern of the safety of the Patin lot on Harding.

Yvette moves that the board make the effort to have Hastings Heights included in SHNCPID per their \$100.00 per lot assessment.
